CODE OF CONDUCT

The Word of God commands us to “abstain from all appearance of evil”. We at Royal C Ranch Summer Camps, desiring the full blessings of God on the Ministry and on the lives of those who attend, have established the following rules for this very purpose. Royal C Ranch Summer Camps is a ministry extension of the local New Testament Church. The standards that we maintain have not and will not change. Pastor, it is our desire that Royal C Ranch Summer Camps uphold and maintain the standards and convictions that you maintain and preach from your pulpit.

No alcoholic beverages, tobacco, iPods, laptops, guns, knives, magazines, books, fireworks, weapons, video games, or playing cards allowed.

All medications must be turned into the sponsor responsible for your group. No clothing with inappropriate advertising or graphics. No physical contact allowed between male and female campers! A male and female should never be alone or in an unlit area with each other at any time.

LADIES CODE OF CONDUCT

* Modest, loose fitting skirts, dresses, culottes (skirt-like: full, not fit- ted) no gauchos or walking shorts or gym shorts, no hip hugger skirts or culottes, skirts and culottes cannot be worn below the waist. If you do not have the proper culottes, you may borrow them at the Camp. Culottes and skirts must always be below the knee cap when sitting, standing, kneeling, etc.

* Modest tops and blouses. No sleeveless tops or dresses. No slits above the knee.

* No form fitting or sheer dresses; no crop tops. *No sun dresses with narrow straps and low necklines.

* No pants of any style, jam or basketball shorts, or sweat pants.

* Nice dress clothes are to be worn for evening services.

GENTLEMEN'S CODE OF CONDUCT

* No sleeveless shirts.

* Gentlemen must wear long pants for activities; no shorts or sweat pants. No “baggy” or “tight” pants allowed. Wind pants may be worn for sports activities. * No earrings, necklaces, or bracelets.

* Nice dress clothes should be worn for evening services.

NOTE: Anyone requiring special dietary foods **MUST** bring their own food if supplementing beyond regular meals is required.

Any camper failing to abide by Camp rules will be taken home at the church's expense. We ask that all visitors abide by the same guidelines. Final decisions concerning rules will be up to the Camp Director. **NO REFUNDS AFTER REGISTRATION.**

What To Bring To Camp

- Complete set of toiletries: towels, washcloths, toothbrush, soap, deodorant, flip flops for shower etc.
 - Bedding: linens/sleeping bag (twin size bed), pillow, blankets etc.
- Camp Approved Clothing: sportswear, nicer casual clothes for evening services and competitions if participating (Everyone must arrive and depart in camp approved clothing- refer to dress code).
- Sleepwear: Boys should wear a minimum of shorts or pants. Girls should wear a minimum of shorts/pants and top or nightgown (sleepwear should only be worn in cabins).
 - Jacket or Sweatshirt
 - KJV Bible, Notebook and Pen
- Everyone must participate in all sports and activities (unless physically or medically not able).
- Spending Money: snack shop, gift shop, paintball (climbing wall is free of charge)
 - Good Attitude!
